## WAIVER AND RELEASE FROM LIABILITY

For and in consideration of the privilege granted to me to participate in activities coordinated by the Honeywell Sportsman Club, the undersigned hereby agrees as follows:

1. I hereby acknowledge and understand that the Honeywell Sportsman Club is a group affiliated with the Honeywell Employees Club, an independent group of employees of various divisions of Honeywell, Inc.
2. I further understand and acknowledge that the members of the Honeywell Sportsman Club do not represent themselves to be qualified or experienced instructors, guides, or leaders for activities coordinated or conducted by the Honeywell Sportsman Club.
3. As to any activity coordinated or conducted by the Honeywell Sportsman Club, I hereby expressly agree as follows:
  - a. I understand and am aware of the risks and hazards of participating in an activity coordinated or conducted by the Honeywell Sportsman Club.
  - b. In participating in any activity coordinated or conducted by the Honeywell Sportsman Club, I do so voluntarily and in my individual capacity; I expressly understand that I am not in the care or control of the Honeywell Sportsman Club or the Honeywell Employees Club, or any member thereof; and I attest that I am physically and mentally fit to participate.
  - c. As to any activity coordinated or conducted by the Honeywell Sportsman Club in which I shall participate, I understand and agree that I will be responsible for all of my own actions and must rely upon my own judgment during all times of such activity.
4. I hereby expressly assume all risk of loss, damage, or injury, to my property or person, including death, that I may or shall sustain by reason of or in connection with my participation in any activity coordinated or conducted by the Honeywell Sportsman Club.
5. For myself, and on behalf of my heirs, administrators, executors, and assigns, I hereby release, relinquish, waive, surrender, and discharge the Honeywell Sportsman Club, its members and participants and the Honeywell Employees Club of and from any liability, claims, demands, actions, causes of action, and all debts,

whatever and to whomsoever, which I now have or may in the future have in connection with any injury to my property or person, including death, in connection with, arising out of, or resulting from any activity in which I shall participate, regardless of the cause or extent of such injury, claim, loss, or damage.

6. I understand and acknowledge that any activity in connection with the Honeywell Sportsman Club in which I may participate is in no way an activity sponsored by Honeywell, Inc., or any of its divisions; and that the Honeywell Employees Club and the Honeywell Sportsman Club are separate, distinct, independent, and autonomous entities in no way subject to the care or control of Honeywell, Inc., or its divisions. I hereby expressly waive and disclaim any and all liability, claims demands, action, causes of actions, and/or debts whatever which I may now have or which my heirs, administrators, executors, or assigns may in the future have against Honeywell, Inc., or any of its divisions in connection with injury to or death of my person or dependents as shown hereon or injury to my property arising out of my participation in any activity of the Honeywell Employees Club or the Honeywell Sportsman Club.
7. I understand that the activities referred to in the preceding statement include, but are in no way limited to, formal and informal firearm and archery matches, reloading, meetings, camping, fishing, and instructional courses.
8. I have received and read the current Arizona Firearms law(s) and agree that I will abide by those laws and any additional laws that may be passed in the future during any Honeywell Sportsman Club activities.

I HEREBY REPRESENT AND ACKNOWLEDGE THAT I HAVE READ THIS WAIVER AND RELEASE FROM LIABILITY, FULLY UNDERSTAND EACH AND EVERY PROVISION, AND HAVE ON THIS DATE VOLUNTARILY EXECUTED SAME. I FURTHER REPRESENT AND WARRANT THAT I AM OF SOUND MIND AND AM AT LEAST 18 YEARS OF AGE AND HAVE THE LEGAL CAPACITY TO EXECUTE THIS AGREEMENT. UNLESS CANCELLED BY ME IN WRITING, THIS WAIVER IS TO HAVE FULL EFFECT AT ALL ACTIVITIES AND EVENTS DURING THE MEMBERSHIP CALENDAR YEAR.
